## Trademark Assignment



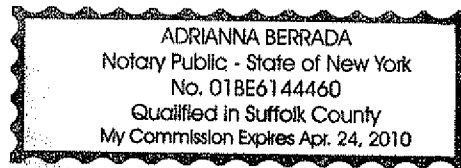
