This Agreement is made on the 31st day of December 2007

Between:

- (1) De Beers Centenary AG, a company incorporated in Switzerland, whose registered office is at Alpenstrasse 5, 6000 Luzern 6, Switzerland formerly of Langensandstrasse 27, 6000 Luzern 14, Switzerland ("DBCAG")
- (2) Gitanjali Ventures DMCC, a company incorporated in Dubai, whose registered office is at Level 41, Emirates Towers, Shaikh Zayed Road, Dubai, United Arab Emirates ("Assignee")

Whereas:

- (A) DBCAG owns the Trade Marks
- (B) DBCAG has agreed to assign the Trade Marks to the Assignee on the following terms

The parties agree and declare as follows:

1 Interpretation

In this Agreement:

"Effective Date" means the date of this Agreement; and

"Trade Marks" means the mark "NAKSHATRA" and the Applications and registered trade marks listed in the Schedule to this Agreement together with the goodwill attached to them, brief details are set out in the Agreement's Schedule

2 Assignment

DBCAG hereby assigns and transfers to the Assignee with effect from the Effective Date all its right, title and interest in and to the Trade Marks including, without limitation, all goodwill and rights of action in respect of the Trade Marks, the right to seek and recover damages and seek other remedies for all past infringement of the Trade Marks and the right to be entered on the register as the proprietor of the Applications upon registration

3 Consideration

The consideration for assignment of the Trade Marks pursuant to Clause 2 shall be ten dollars (US\$10.00) receipt of which is hereby acknowledged by DBCAG.

4 No Representations or Warranties

DBCAG gives no warranties or representations in respect of the Trade Marks, including, without limitation, in respect of the validity or enforceability of the Trade Marks.

5 Recordal

The Assignee undertakes that it shall, within 6 months of the date of this Agreement, apply to and record with the Trade Marks Registry in each of the designated territories the assignment noted in this Agreement, in particular, the Assignee as the subsequent proprietor of the Trade Marks.

6 **Governing Law and Jurisdiction**

This Agreement shall be governed by and construed in accordance with the laws of England and Wales and the parties agree that the courts of England and Wales are to have non-exclusive jurisdiction to settle any disputes which may arise out of or in connection with this Agreement.
