ASSIGNMENT OF TRADEMARKS

BAC hereby sells, assigns and transfers unto ABN its entire right, title and interest of every kind in and to the Trademarks including the registered trademarks listed on Schedule A, together with all goodwill associated therewith, and all rights to sue or recover and retain damages and costs and attorneys' fees for past, present and future infringement or misappropriation of any of the foregoing in all countries of the world.



BAC hereby agrees to sign all necessary papers and do all lawful acts reasonably requisite in connection with the prosecution, assignment, enforcement and disclaimer of each and every trademark application based upon the Trademarks, without further compensation, but at the expense of ABN or its successors and assigns. BAC hereby authorizes and requests the officials of all countries in which the applicable Trademarks are now issued, or in the future will be issued, to grant to ABN all of BAC's entire right, title and interest in and to the same for the sole use and enjoyment of ABN, its successors and assigns.

3. This Assignment may be executed in any number of counterparts each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement.




