Sorenson Medical, Inc., (hereinafter referred to as the "**Corporation**"), a corporation duly organized and existing under the laws of the State of Utah, hereby amends its Articles of Incorporation, as previously amended, in accordance with the provisions of §§16-10a-1001 et seq. of the Utah Revised Business Corporation Act, as amended, as follows

FIRST The name of the Corporation is Sorenson Medical, Inc

SECOND The name of the Corporation is changed to "**SMI LIQUIDATING, INC.**" and Article I of the Corporation's Articles of Incorporation is deleted in its entirety and the following Article I is inserted in lieu thereof

ARTICLE I

NAME

The name of the corporation is "**SMI LIQUIDATING, INC**"

THIRD All other provisions of the Articles of Incorporation of the Corporation shall remain as presently constituted

FOURTH This Amendment was duly adopted by all of the directors and the shareholders of the Corporation by written consent effective the 21ST day of DECEMBER, 2007

FIFTH The shares of the Corporation's capital stock are designated as voting common stock, non-voting common stock and non-voting preferred stock, of which there were 10,000,000 shares of voting common stock issued and outstanding at the time of the aforementioned written consent. All of the shares of the Corporation's common stock outstanding at the time of adoption of the Amendment that were entitled to vote for the adoption were cast in favor of the Amendment by written consent, and no votes were cast against
