## NUNC PRO TUNC TRADEMARK ASSIGNMENT

This **NUNC PRO TUNC TRADEMARK ASSIGNMENT** (this "Assignment") is made effective as of November 30, 2006 by and between **UTILICOM NETWORKS, LLC**, a Delaware limited liability company ("Assignor"), and **SIGECOM, LLC**, a Delaware limited liability company ("Assignee").

**WHEREAS**, pursuant to the Equity Purchase Agreement dated as of August 10, 2006 (the "Purchase Agreement") by and among Assignor, Sigecom Holdings, Inc. (together with Assignor, "Sellers"), WideOpenWest Finance, LLC ("Buyer") and Assignee, Buyer purchased all of the membership interests of Assignee from Sellers.

**WHEREAS**, Assignor desires to assign to Assignee and Assignee desires to acquire from Assignor, effective as of the Closing Date (as defined in the Purchase Agreement), the United States trademark registration set forth on Schedule A attached hereto (the "Mark").

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby sells, transfers, conveys, assigns and delivers to Assignee, all of Assignor's right, title and interest in and to the Mark, including, without limitation, any registrations and applications therefor, any renewals and extensions of the registrations, all goodwill associated with any of the foregoing, and all other corresponding rights that are or may be secured under the laws of the United States or any foreign country, now or hereafter in effect, for Assignee's own use and enjoyment, and for the use and enjoyment of Assignee's successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment had not been made, including, without limitation, all claims for damages by reason of past, present or future infringement or other unauthorized use of the Mark, with the right to sue for, and collect the same for Assignee's own use and enjoyment and for the use and enjoyment of its successors, assigns or other legal representatives.

Assignor hereby agrees that Assignee may, on behalf of Assignor, request that the Commissioner of Patents and Trademarks record Assignee as the assignee and owner of the Mark.
