**DECLARATION REGARDING OWNERSHIP**

Donata Campiche declares as follows:

1. I am a Trademark Attorney with the firm, Lemman Consulting S.A., Nyon, Switzerland, and Lemman Consulting S.A. is representing Nagra France SAS in connection with various trademark matters, including the maintenance of U.S. Registration No. 2,498,529 for the mark MEDIAGUARD issued October 16, 2001.

2. I have reviewed the French Companies and Trade Register and have determined that the only "Canal + Technologies" registered on the Companies and Trade Register during the relevant period was Canal + Technologies, a "Societe Anonyme" or "S.A." An Abstract as of January 19, 2004 in French evidencing the fact that Canal + Technologies S.A. was registered December 22, 1994 (together with an English translation of such Abstract) is attached to this Declaration.


3. From my review of the French Companies and Trade Register the only entity to which U.S. Registration 2,498,529 could have been assigned by Canal + in the assignment dated July 24, 2003 recorded October 22, 2003 at Reel/Frame 2898/0588 was Canal + Technologies S.A.

4. It is clear to me that the "Canal + Technologies" referred to in the assignment from Canal + dated July 24, 2003 and recorded October 22, 2003 at Reel/Frame 2898/0588 is Canal + Technologies S.A. and that the designation "S.A." was inadvertently omitted from that assignment.

5. Since the party receiving the assignment from Canal + on July 24, 2003 was Canal + Technologies, S.A. there is no break in the chain of title and Canal + Technologies S.A., as the owner of U.S. Registration No. 2,498,529, properly assigned all right, title and interest in U.S. Registration No. 2,498,529 to Nagra France SARL in the assignment dated June 18, 2004 and recorded February 18, 2005 at Reel/Frame 003032/0418.
