## TRADEMARK RIGHTS ASSIGNMENT

THIS ASSIGNMENT, by and between AIR PRODUCTS AND CHEMICALS, INC., a Delaware corporation, ("APCI") and ASHLAND LICENSING AND INTELLECTUAL PROPERTY LLC, a Delaware Limited Liability Company ("ASHLAND"), effective as of July 1, 2008.

APCI and ASHLAND INC. have entered into a Purchase Agreement dated as of June 6, 2008 (the "PA") whereby APCI and ASHLAND INC. have agreed, among other things, for the transfer to ASHLAND INC. of the Business as defined in the PA.

APCI owns the entire right, title and interest in and to the trademarks and the trademark registrations listed on Schedule A attached hereto and made a part hereof and to the goodwill of the business associated with the aforesaid trademarks and the trademark registrations, all of which comprised a part of the Business;

Section 1.02(a)(v) of the PA requires that APCI assign to ASHLAND INC. (or its designee) all right, title and interest in the trademarks and the trademark registrations to conduct and operate the Business. ASHLAND INC. has designated ASHLAND to acquire and ASHLAND is desirous of acquiring all of APCI's right, title and interest to the trademarks and the trademark registrations listed on Schedule A; and

NOW, THEREFORE, in consideration of the mutual promises, undertakings and covenants contained in the PA, APCI does by these presents assign, convey, transfer and deliver to ASHLAND, its successors and assigns, the entire right, title and interest, worldwide, in and to the trademarks and the trademark registrations listed on Schedule A, including all claims for damages for past infringement, together with the goodwill of the business associated with said trademarks and trademark registrations.

APCI agrees with ASHLAND and ASHLAND INC. to execute and deliver, or cause to be executed and delivered, and to do or make or cause to be done or made, upon reasonable request by ASHLAND or ASHLAND INC., any and all instruments, papers, deeds, acts or things, supplemental, confirmatory or otherwise, as may be reasonably required by ASHLAND for the purpose of or in connection with more effectively vesting in ASHLAND or evidencing the vesting in ASHLAND of the aforesaid trademarks and trademark registrations listed on Schedule A, pursuant to Section 5.12 of the PA.

These obligations of APCI shall survive closing related to the PA and shall continue for so long as ASHLAND and ASHLAND INC. may require such assistance from APCI.
