AGREEMENT OF MERGER OF

NEWPORT EAST, a California corporation
AND

TRUCKER'S PUBLICATIONS, INC., a California corporation

INTO

H.I.C. CORPORATION, a California corporation

THIS AGREEMENT OF MERGER (the "Agreement") is entered into between Newport East, a California corporation, and Trucker's Publications, Inc., a California corporation, (collectively referred to as the "Merging Corporations") and H.I.C. Corporation, a California corporation (the "Surviving Corporation").

1. The Merging Corporations shall be merged with and into the Surviving Corporation, which shall possess all the properties and assets and all the rights, privileges, powers, immunities and franchises of whatever nature and description, and shall be subject to all restrictions, disabilities, duties and liabilities of the Merging Corporations; and all such things shall be taken and deemed to be transferred to and vested in the Surviving Corporation without further act or deed; and the title to any real estate or other property, or any interest therein, vested by deed or otherwise in the Merging Corporations shall be vested in the Surviving Corporation without reversion or impairment.

2. The Articles of Incorporation and Bylaws of H.I.C. Corporation shall be the Articles of Incorporation and Bylaws of the Surviving Corporation.

3. The name of the Surviving Corporation shall be changed to "Newport Communications Group, Inc.", and Article I of the Articles of Incorporation of the Surviving Corporation shall be amended to read as follows:

"The name of this corporation is Newport Communications Group, Inc."

4. The total issued and outstanding shares of each Merging Corporation shall be converted to one (125) shares of common stock of Surviving Corporation.

5. Merging Corporations shall from time to time, as and when requested by Surviving Corporation, execute and deliver all such documents and instruments and take all such action necessary or desirable to evidence or carry out this merger.


6. The merger shall be effective as of December 31, 2003.
