## **TRADEMARK SECURITY AGREEMENT SUPPLEMENT**

**WHEREAS**, Stream Gas & Electric, Ltd., a Texas limited partnership (herein referred to as the "Licensor") having an address at 1950 Stemmons Freeway, Suite 6053, Dallas, Texas 75207, has adopted, used, and is using the trademarks, trade names, trade styles and service marks listed on the annexed Schedule I-A, which trademarks, trade names, trade styles and service marks are registered in the United States Patent and Trademark Office (the "Trademarks");

**WHEREAS**, Licensor has granted to Stream Georgia Gas SPE, LLC, a Georgia limited liability company (herein referred to as the "Debtor"), having an address at 1950 Stemmons Freeway, Suite 6053B, Dallas, Texas 75207, a license to use the Trademarks pursuant to and in accordance with the terms of that certain License Agreement dated as of February 20, 2008, between Licensor and Debtor (as amended or otherwise modified from time to time, the "Trademark License Agreement");

**WHEREAS**, Debtor has entered into an ISDA Master Agreement dated as of February 20, 2008, with Constellation Energy Commodities Group, Inc. (together with its successors and assigns, "Secured Party"), and all schedules, annexes, confirmations, and transactions thereunder (as amended or otherwise modified from time to time, the "ISDA Master Agreement");

**WHEREAS**, in connection with the ISDA Master Agreement Debtor has entered into a Security Agreement dated as of February 20, 2008 (as amended, supplemented, replaced, or otherwise modified from time to time, the "Security Agreement") in favor of Secured Party, pursuant to which Debtor has granted to Secured Party, a security interest in all present and future right, title, and interest of Debtor in and to the Trademark License Agreement, including Debtor's rights to use the Trademarks and all reissues, renewals, and extensions thereof thereunder and all proceeds thereof (the "Collateral"), to secure the payment, performance, and observance of the Secured Obligations (as defined in the ISDA Master Agreement);


**NOW, THEREFORE**, for good and valuable consideration, receipt of which is hereby acknowledged, Debtor does hereby further confirm, and put on the public record, its grant to Secured Party of a security interest in the Collateral to secure the prompt payment, performance and observance of the Secured Obligations.

Debtor does hereby further acknowledge and affirm that the rights and remedies of Secured Party with respect to the grant of, security interest in and mortgage on the Collateral made hereby are more fully set forth in the Security Agreement; the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.
