


ASSIGNMENT OF TRADEMARK

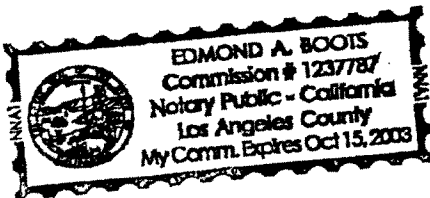
