PURSUANT TO THE PROVISIONS OF THE NEW HAMPSHIRE BUSINESS CORPORATION ACT, THE UNDERSIGNED CORPORATION ADOPTS THE FOLLOWING ARTICLES OF AMENDMENT TO ITS ARTICLES OF INCORPORATION:

FIRST: The name of the corporation is American Traditional Designs, Inc.

SECOND: The text of each amendment adopted is:

To amend Article I of the Corporation's Articles of Incorporation by deleting said Article I in its entirety and replacing it with the following so that Article I will thereafter read as follows:

“ARTICLE I

To amend Article II of the Corporation's Articles of Incorporation by deleting said Article II in its entirety and replacing it with the following so that Article II will thereafter read as follows:
