
ASSIGNOR further assigns to ASSIGNEE all right to sue for and receive all damages accruing from past infringements of the TRADEMARK herein assigned.

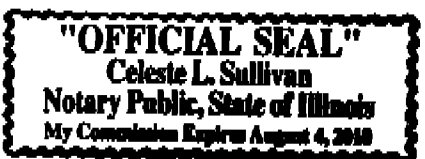
