THIRD: The name of the surviving corporation is Sonic Branding Solutions, Inc.

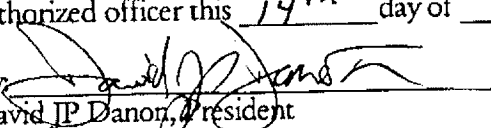
FOURTH: The merger is to become effective on the date this Certificate of Merger is filed with the Secretary of State of Delaware.

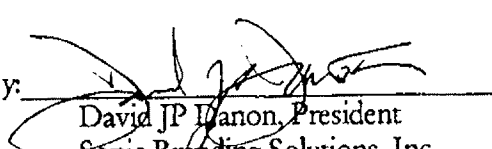
SEVENTH: The Certificate of Incorporation of the surviving corporation shall be its Certificate of Incorporation.
