Pursuant to Section 347.725 of the Missouri Revised Statutes, as amended:

First: The names of the constituent entities are:

Con-way Truckload LLC, a Delaware limited liability company ("Con-way") and
Contract Freighters, Inc., a Missouri corporation ("Surviving Corporation").

Second: The Agreement and Plan of Merger ("Agreement") has been approved and executed by
both Con-way and the Surviving Corporation in accordance with section 347.720.

Third: The effective date of the merger between Con-way and the Surviving Corporation shall
be January 1, 2008.

Fourth: The name of the surviving entity is Contract Freighters, Inc.
