**BILL OF SALE, ASSIGNMENT AND ASSUMPTION AGREEMENT**

THIS BILL OF SALE, ASSIGNMENT AND ASSUMPTION AGREEMENT is made and executed on May 11, 2004, by Jobview.com, L.P., a Minnesota limited partnership ("Assignor"), and Jobview, LLC, a Minnesota limited liability company ("Assignee").

1. Assignor does hereby sell, assign, transfer, convey and deliver to Assignee, all of its right, title and interest in and to all of its assets, and assigns to Assignee, all of its liabilities and obligations, effective as of 11:59 p.m. on May 11, 2004.
2. Assignee hereby assumes such liabilities and obligations and agrees to fully and timely perform and hold Assignor harmless from and against all of the obligations, duties and liabilities of Assignor under such assumed liabilities and obligations from and after the effective date of this Bill of Sale, Assignment and Assumption Agreement.
3. This Bill of Sale, Assignment and Assumption Agreement shall be binding upon and inure to the benefit of and be enforceable by the successors and assigns of the parties.
4. No provision of this Bill of Sale, Assignment and Assumption Agreement may be amended, modified or waived, except by an instrument in writing signed by the parties.
5. This Bill of Sale, Assignment and Assumption Agreement shall be governed in all respects, including validity, interpretation and effect, by the laws of the State of Minnesota.
