TRADEMARK ASSIGNMENT

Assignor hereby requests the Commissioner of Patents and Trademark to record Assignee, as assignee and owner of any and all of Assignor's joint ownership right in the Trademark and to issue to Assignee any renewals of said registration.

Assignor agrees to execute and deliver at a future date, for no additional consideration any additional documents that the Assignee reasonably determines are required to reflect the Assignee's ownership of the Trademark anywhere in the world.

Assignor will assist in obtaining or providing any further documents which may be required to confirm chain or title thereto.

This Assignment may be signed in counterparts, each of which shall be deemed an original, but together shall constitute a single instrument.

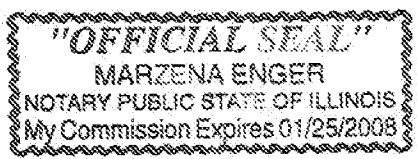

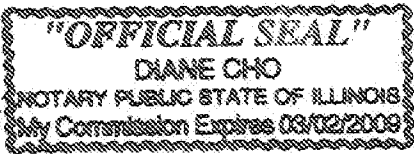
