ASSIGNMENT

THIS ASSIGNMENT OF TRADEMARKS is entered into by and between **AMER SPORTS INTERNATIONAL OY**, a Finnish corporation, residing at Makelankatu 91, FI-00601 Helsinki, Finland ("Assignor"), and **CLUBCOM, INC.**, a Delaware corporation, residing at 100 Business Center Drive, Suite 100, Pittsburgh, Pennsylvania 15205, U.S. ("Assignee") with reference to the following facts:

WHEREAS, Assignor is the lawful owner-of-record of all rights, title and interest in European Community Trademark Registration No. 4474581 for the trademark CLUBCOM in International Classes 9, 28, 35, 38 and 41, and U.S. Trademark Application Serial No. 77468382 for the trademark CLUBCOM in International Classes 9, 35, 38 and 41 (hereinafter referred to as the "CLUBCOM Trademarks"); and

WHEREAS, Assignee is desirous of acquiring any and all rights, title and interest in and to the CLUBCOM Trademarks, including all common law rights connected therein, and all goodwill of the business relating to the trademark CLUBCOM in association with the goods and services of the CLUBCOM Trademarks.

NOW, THEREFORE, in consideration of the above, the terms and conditions hereinafter set forth, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto, intending to be legally bound, agree as follows:

Assignor does hereby sell, transfer and convey to Assignee all rights, title and interest in and to the CLUBCOM Trademarks, all common law rights connected therein, and all goodwill of the business relating to the trademark CLUBCOM in association with the goods and services of the CLUBCOM Trademarks.

Assignor hereby agrees to provide all reasonable assistance to Assignee, its successors and assigns, in obtaining proper title in the CLUBCOM Trademarks under the intellectual property laws of the United States and Europe.

This Agreement represents the entire agreement of the parties, shall be governed by the laws of the state of Delaware, and shall be binding upon the parties, their successors and assigns.
