**Articles of Amendment

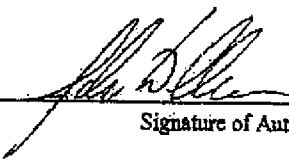

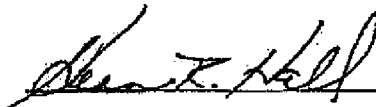
