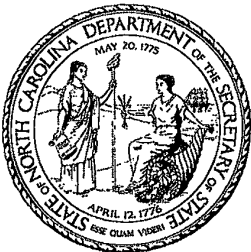

2. The address of the surviving entity is:


