TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT ("Assignment") is made as of July 17, 2008, from MICHAEL S. POLSKY, as the court-appointed receiver of RAFFEL COMFORT SCIENCES, LLC, a Wisconsin limited liability company ("Assignor") to RAFFEL SYSTEMS, LLC, a Wisconsin limited liability company ("Assignee").

RECITALS

A. On June 5, 2008, Michael S. Polsky was appointed as the receiver under the provisions of Chapter 128 of the Wisconsin Statutes in the Circuit Court for Ozaukee County, Wisconsin.

B. Assignee has agreed to purchase certain assets of Raffel Comfort Sciences, LLC including the Assigned Trademarks (as described below) through a court approved sale under Chapter 128 of the Wisconsin Statutes pursuant to an Asset Purchase Agreement dated as of July 10, 2008.

C. Assignor desires by execution of this Assignment to confirm the assignment of all rights, title and interest in and to the Assigned Trademarks to Assignee, and Assignee desires by execution of this Assignment to confirm the assignment of all of Assignor's rights, title and interest in the Assigned Trademarks from Assignee.

AGREEMENT

For valuable consideration (including that recited in the Asset Purchase Agreement), the receipt and sufficiency of which is hereby acknowledged, Assignor hereby assigns the Assigned Trademarks as follows:

1. Definition of Assigned Trademarks. The term "Assigned Trademarks" shall mean the trademark registrations and common law trademarks listed in Appendix A, as well as: (a) all common law rights therein; (b) all goodwill associated therewith; (c) all renewals thereof; and (d) all rights of action, powers and benefits accrued thereto, including the right to sue for and collect damages and payments for past or future infringements thereof.

2. Assignment of the Assigned Trademarks. Assignor hereby sells, assigns, and transfers to Assignee, its successors and assigns all of Assignor's right and title to and interest in the Assigned Trademarks.

3. Further Assurances. Assignor further agrees to take all reasonable and necessary steps to implement the provisions of the Assignment.


