**TRADEMARK ASSIGNMENT**

WHEREAS, Richard Danziger, an individual having an address of 200 Grand Cove Way, Suite 4M, Edgewater, New Jersey 07020, hereinafter called "Assignor," being the owner of all right, title and interest in the following:

1. U.S. Trademark Registration 1,595,320, issued on May 8, 1990, for BANKERS, covering "specialty advertising products, namely, pens, pen refills and pencils distributed and sold either directly or indirectly to those who may want an advertisement forming part of the product"; and
2. U.S. Trademark Registration 511,270, issued on June 21, 1949, for BANKER, covering ball pens (collectively hereinafter "the MARKS").

WHEREAS, Bankers Pen Co. Inc., a Corporation organized and existing under and by virtue of the laws of the State of Delaware, and having a place of business at 120 12<sup>th</sup> Street, Brooklyn, NY 11215, hereinafter called "Assignee", is desirous of acquiring the MARKS together with the goodwill of the business symbolized by the MARKS and all rights, title and interest in the United States, associated therewith.

NOW, therefore, for good and valuable consideration, receipt of which is hereby acknowledged, Assignor hereby sells, transfers and sets over to Assignee, his entire right, title and interest in and to the MARKS, together with the associated goodwill of the business symbolized by the MARKS throughout the United States, its territories, and/or possessions and armed forces PX's, wherever located, including without limitation: any U.S. or state trademark application(s), renewals and maintenance of the resulting registration(s), together with all claims for damages by reason of past infringement of the MARKS, with the right to sue for, and collect the same for its own use and behalf, and for the use and behalf of its successors, assigns or other legal representatives.
