RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE dated as of June 16, 2008 (this "Release") is made by Comerica Bank, as Agent ("Secured Party") under the security agreement ("Security Agreement") dated as of December 21, 1999 and recorded on September 11, 2006 in the records of the United States Patent and Trademark Office at Trademark Reel 003387, Frame 0541, between Eurodesign Holdings, Inc., a Delaware corporation, Eurodesign Cabinets, Inc., a California corporation ("Debtors"), and Secured Party.



NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Secured Party does hereby release its security interest in the Trademarks, and discharges, quit claims and relinquishes unto Debtors (in each case without recourse and without any representation or warranty) any and all right, title and interest it has in and to the Trademarks under the Security Agreement.
