ASSIGNMENT OF U.S. TRADEMARK RIGHTS

**NOW, THEREFORE**, for good and valuable consideration, receipt and sufficiency of which is acknowledged, Waymade does hereby sell, assign and transfer to Amdipharm International all right, title and interest in and to the mark AMDIPHARM in the United States, in and to U.S. Reg. No. 2,909,621, together with the goodwill in the United States of the business symbolized by the mark AMIDPHARM, including the right to recover for past infringements thereof.
