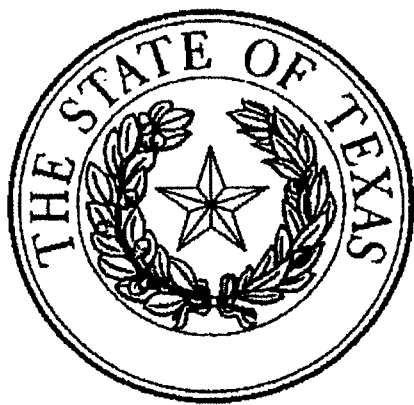

This document becomes effective when the document is filed by the Secretary of State.


