2.2. **By All Parties.** Each party warrants that he is authorized to execute this agreement and that this agreement will constitute a legally binding obligation of himself or Company or other entity that the individual represents.


3. **Consent to Transfer.** By executing this agreement, each party expresses his consent to transfer of the mark ownership evidenced by this assignment.


