TERMINATION AND RELEASE OF  
SECURITY INTEREST IN TRADEMARKS

This TERMINATION AND RELEASE ("Termination and Release"), dated as of January 9, 2009, from CITIBANK, N.A., a national banking association having a principal place of business at 388 Greenwich Street, New York, New York 10013, as administrative agent (the "Agent") for itself and the several banks and other financial institutions that are parties to the Credit Agreement (as hereinafter defined), to ALLTEL COMMUNICATIONS, LLC (successor to ALLTEL COMMUNICATIONS, INC.), a Delaware limited liability company having its principal place of business at One Allied Drive, Little Rock, Arkansas 72202 (the "Borrower") and certain Subsidiaries of ALLTEL CORPORATION, a Delaware corporation and parent of the Borrower (the "Parent") (each of the Borrower and the Subsidiaries of the Parent listed on Annex A attached hereto, the "Grantors"). Capitalized terms used herein without definition are used as defined in the Credit Agreement, dated as of November 16, 2007, among the Agent, the Borrower, the Parent, and each lender from time to time party thereto (as amended, supplemented or otherwise modified from time to time, the "Credit Agreement") and the Security Agreement (as hereinafter defined).

WITNESSETH:

WHEREAS, pursuant to that certain Trademark Security Agreement, dated as of November 16, 2007, among the Borrower, certain Subsidiaries of the Parent from time to time party thereto and the Agent (as amended, supplemented or otherwise modified from time to time, the "Security Agreement"), a security interest (the "Security Interest") was granted by the Grantors to the Agent in the Trademark Collateral (as hereinafter defined); and

WHEREAS, the Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on November 16, 2007, at (i) Reel 3663, Frame 0540 (with respect to Trademark Collateral owned by Alltel Communications, LLC) (ii) Reel 3662, Frame 0438 (with respect to Trademark Collateral owned by Western Wireless Corporation) and (iii) Reel 3662, Frame 0367 (with respect to Trademark Collateral owned by Southern Illinois RSA Partnership); and

WHEREAS, the Borrower has requested the Agent to terminate and release the entirety of the Agent's Security Interest in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Agent hereby states as follows:

1. Trademark Collateral: The term “Trademark Collateral,” as used herein, shall mean (a) all trademarks, service marks, trade names, corporate names, company names, business names, Internet domain names, trade dress, logos, designs and general intangibles of a like nature, fictitious business names, other source or business identifiers, now existing or hereafter adopted or acquired, including without limitation, all registrations and recordings thereof, and all registration and recording applications filed in connection therewith, including registrations and registration applications in the USPTO or any similar offices in any State of the United States or any other country or any political subdivision thereof, and all extensions or renewals thereof, as well as any unregistered or common law trademarks and service marks used by a Grantor, including, without limitation, those listed in Schedule I, (b) all goodwill connected with the use of and symbolized thereby, and (c) all other assets, rights and interests that uniquely reflect or embody such goodwill.

2. Release of Security Interest: The Agent hereby terminates, releases and discharges its Security Interest in the Trademark Collateral, and any right, title or interest of the Agent in such Trademark Collateral shall hereby cease and become void.


3. Further Assurances: In each case upon the reasonable request of the Borrower, the Agent shall execute and deliver to the Grantors all further releases and other documents (including without limitation Uniform Commercial Code termination statements) and take all other actions reasonably requested by the Borrower for the release of the Security Interest. Any actions taken pursuant to the foregoing shall be at the sole expense of the Borrower, and the Agent shall be entitled not to take any actions pursuant to the foregoing absent payment of the Agent’s fees and expenses in connection with any of the foregoing.
