RELEASE OF TRADEMARK SECURITY INTEREST

THIS RELEASE OF TRADEMARK SECURITY INTEREST ("Release") is made effective as of December 19, 2008 by The Royal Bank of Scotland plc (the "Security Trustee") to Whitmire Micro-Gen Research Laboratories, Inc., (the "Grantor"), as follows:

WHEREAS, on June 9, 2004, the Grantor and the Security Trustee entered into a Security Agreement ("Security Agreement");
