IN INTELLECTUAL PROPERTY**


Reference is hereby made to the security interest recorded with the United States Patent and Trademark Office on December 19, 2003, in Reel 2766/Frame 0579, the "**IP Security Agreement**", executed by **MUSIC PLUS, INC.**, a New York corporation ("**Grantor**"), in favor of **GE BUSINESS FINANCIAL SERVICES INC. NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which is hereby acknowledged, Secured Party hereby releases any security interest it may have in the IP Collateral and retransfers and reassigns to Grantor, without representation or warranty, and without recourse, all of Secured Party's right, title and interest in and to the IP Collateral.

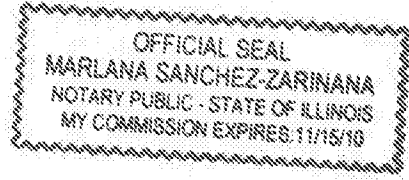
