## TRADEMARK ASSIGNMENT

This Trademark Assignment (this "Assignment") is made and entered into as of February 3, 2009 (the "Effective Date"), by and among **GLOBAT, LLC**, a California limited liability company ("Assignor"), and **THE ENDURANCE INTERNATIONAL GROUP, INC.**, a Delaware corporation ("Assignee").

WHEREAS, Assignor and Assignee are parties to that certain Asset Purchase Agreement dated as of October 28, 2008, as amended by that certain Amendment No. 1 to Asset Purchase Agreement dated as of February 3, 2009 (the "Purchase Agreement"), pursuant to which Assignee has agreed to purchase from Assignor the Assets (as defined in the Purchase Agreement); and

WHEREAS, pursuant to the Purchase Agreement, Assignor has agreed to assign the trademarks set forth on Schedule 1 hereto (the "Marks") to Assignee, and Assignee has agreed to assume the Marks from Assignor, as set forth herein, and this Assignment is contemplated by Section 3.1(b)(iii) of the Purchase Agreement;

NOW, THEREFORE, for and in consideration of the premises and the mutual covenants contained herein, and for other good and valuable consideration, the receipt, adequacy and legal sufficiency of which are hereby acknowledged, the parties do hereby agree as follows:

**1. Capitalized Terms.** Capitalized terms used but not defined herein shall have the meanings for such terms that are set forth in the Purchase Agreement.

**2. Assignment.** Assignor hereby transfers, conveys and assigns to Assignee all right, title and interest throughout the world in and to the Marks, together with all goodwill associated therewith, effective as of the Effective Date. Assignor shall execute such written instruments and extend such other cooperation as may be reasonably necessary to convey the Marks to Assignee.

**3. Terms of the Purchase Agreement.** The terms of the Purchase Agreement, including but not limited to Assignor's representations, warranties, covenants, agreements and indemnities relating to the Assets, are incorporated herein by this reference. Assignor acknowledges and agrees that the representations, warranties, covenants, agreements and indemnities contained in the Purchase Agreement shall not be superseded hereby but shall remain in full force and effect to the full extent provided therein. In the event of any conflict or inconsistency between the terms of the Purchase Agreement and the terms hereof, the terms of the Purchase Agreement shall govern.

**4. Further Actions.** Each of the parties hereto covenants and agrees, at its own expense, to execute and deliver, at the request of the other party hereto, such further instruments of transfer and assignment and to take such other action as such other party may reasonably request to more effectively consummate the assignments and assumptions contemplated by this Assignment.


