2. Section One of the Articles of Incorporation of this corporation is hereby amended and restated in its entirety to read as follows:

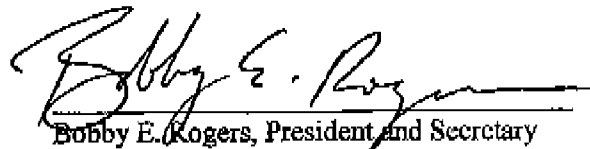
"1. The name of this Corporation is Ivera Medical Corporation."
