## ASSIGNMENT OF TRADEMARKS

THIS ASSIGNMENT is made effective as of January 1, 2009 ("Assignment Date") by Ashbrook Simon-Hartley Limited, a United Kingdom corporation having a place of business at 10/11 Brindley Court, Lymedale Business Park, Newcastle-Under-Lyme, Staffordshire, Great Britain ST5-9QH ("Assignor"), to Ashbrook Simon-Hartley Operations, L.P., having a place of business at 11600 East Hardy Street, Houston, Texas ("Assignee").

WHEREAS, Assignor has adopted and intends to use, and thereby owns, all rights, title and interests in and to the trademarks and applications for registration thereof, identified in Exhibit A attached hereto and by this reference incorporated herein (the "Marks," and "Applications for Registrations," and any "Registrations" resulting therefrom, respectively), along with the goodwill of the business appurtenant to said Marks; and

WHEREAS, Assignor has agreed to transfer and assign to Assignee its entire rights, title and interests in and to the Marks, Applications for Registrations, and any Registrations resulting therefrom, and the goodwill appurtenant thereto;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged:

1. Assignor does hereby irrevocably sell, assign, convey and transfer to Assignee, its successors, assigns and legal representatives, its full and entire rights, title and interests throughout the world in and to the Marks, Application for Registrations, and all Registrations resulting therefrom, and the attendant goodwill symbolized by the Marks, the same to vest in Assignee, including, without limitation, the ownership of all causes of action for, and claims for damages by reason of, the infringement of the Marks, or any of them, which actions and claims arose prior to the Assignment Date.


2. Assignor hereby authorizes and requests the appropriate officers in the United States Patent and Trademark Office and all relevant non-United States Patent and Trademark Offices to issue any and all trademarks granted upon applications identified in Exhibit A to Assignee for the sole use and enjoyment of Assignee, and to record this Assignment for the Marks, Applications for Registration, and Registrations so as to establish Assignee as owner of record of the Marks, Applications for Registration, and Registrations.

3. Assignor further agrees for itself, its predecessors, successors, and assigns, without further consideration, to execute and have executed any and all other documents of any kind whatsoever necessary to fully secure to Assignee, or to Assignee's successors-in-interest or assigns, the assigned rights in the Marks, Applications for Registrations, and Registrations along with the goodwill of the business appurtenant to said Marks, to provide whatever information may be required, to carry out the terms and intent of this Assignment and to fully cooperate with Assignee, as reasonably required, to enable Assignee to duly record this instrument of assignment so that Assignee's ownership of the Marks, Applications for Registration, and Registrations is duly made of record.

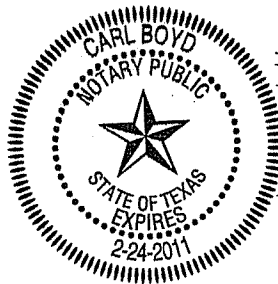


