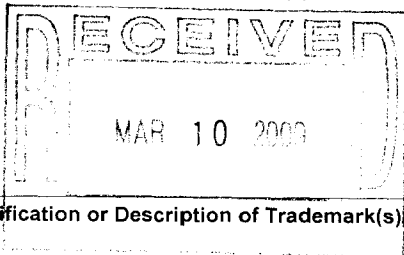

This Assignment is entered into between America Sejung Corp., a California corporation, and Canvas Guitar LLC, a California limited liability company.


