ASSET PURCHASE AGREEMENT

This ASSET PURCHASE AGREEMENT ("**Agreement**") is entered into as of July 22, 2006 between **Excel Machine Tool Ltd. Recitals

- A. "**Excel**" is the recognized owner of **Tree** and has all requisite power and authority to own, sell or license the assets and intellectual properties.
- B. "**Excel**" desires to sell, transfer and assign to **MTM** certain assets and **MTM** desires to purchase such assets from **Excel**, upon the terms subject to the conditions set forth in this agreement.
- C. "**Financial Considerations**" The aggregate fee for the asset purchase of **Tree Machine Tool Co., Inc.**, will be outlined in **Schedule I** of attachments.



This purchase becomes effective upon the date on which the signatures indicated below are made.





Purchase Price

Payment of Purchase Price


The Purchase Price shall be payable as follows:
