ARTICLES OF MERGER  
OF

THESE ARTICLES OF MERGER ("Articles") are adopted and shall be delivered to the Arizona Corporation Commission ("ACC") for filing pursuant to Arizona Revised Statutes ("ARS") §§ 10-1101, 10-1105 and 10-1107 by: (i) INFINITY2, INC., an Arizona corporation ("Merging Corporation"); and (ii) ECOQUEST ACQUISITION, INC., an Arizona corporation ("Surviving Corporation").

ARTICLE I

The Surviving Corporation is duly organized and validly existing under the laws of the State of Arizona, having been incorporated on August 16, 2004. The Merging Corporation is duly organized and validly existing under the laws of the State of Arizona, having been incorporated on March 5, 1993.

ARTICLE II

A Plan of Merger ("Plan") has been filed with the ACC concurrently with the Articles, and contains the terms and conditions of this merger, as required by ARS § 10-1101.B. The boards of directors of both the Merging Corporation and the Surviving Corporation unanimously approved the plan of merger.

ARTICLE III

The name and address of the known place of business of the Surviving Corporation is 14500 N. Northsight Boulevard, Suite 316, Scottsdale, Arizona 85260.

ARTICLE IV

The name and address of the statutory agent of the Surviving Corporation is Corporation Service Company, 2338 W. Royal Palm Road, Suite J, Phoenix, Arizona 85021.


