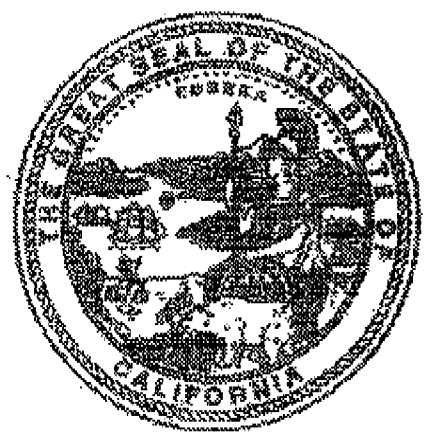

CERTIFICATE OF AMENDMENT TO ARTICLES OF INCORPORATION OF OSABA, INC. a California corporation

THERESE TUCKER and MARIO SPANUCCIATI certify that:

1. They are the President and Secretary, respectively, of OSABA, INC., a California corporation (the "Corporation").

2. Article I of the Articles of Incorporation of the Corporation is amended to read as follows:

"The name of this corporation is BlackLine Systems, Inc."

3. Article IV of the Articles of Incorporation of the Corporation is amended to read as follows:

"The total number of shares which the corporation is authorized to issue is 1,000,000. On amendment of this article, each outstanding share shall be split up and into seventy five (75) shares. Fractional units shall be rounded up or down as applicable to whole shares."

4. The foregoing amendment to the Articles of Incorporation has been duly approved by the board of directors.

The percentage vote required was more than 50%.
