TRADEMARK SECURITY AGREEMENT

TRADEMARK SECURITY AGREEMENT, dated as of January 15, 2009, by the entity listed on the signature page hereof (the "Grantor"), in favor of Guggenheim Corporate Funding, LLC as administrative agent for the Secured Parties (as defined in the Credit Agreement referred to below) (in such capacity, the "Administrative Agent").

Witnesseth:

WHEREAS, pursuant to the Credit Agreement, dated as of December 20, 2006 (as the amended, supplemented or otherwise modified from time to time, the "Credit Agreement"), among Margaritaville Holdings LLC, as Holdings, Margaritaville Holdings II, LLC, as New Holdings, Margaritaville Enterprises, LLC, as the Borrower, the banks and other financial institutions party thereto, as the Lenders, and the Administrative Agent, the Lenders have severally agreed to make extensions of credit to the Borrower upon the terms and subject to the conditions set forth therein;

WHEREAS, the Grantor is party to a Guarantee and Collateral Agreement of even date herewith in favor of the Administrative Agent (the "Guarantee and Collateral Agreement") pursuant to which they have guaranteed the Obligations and to which they are required to execute and deliver this Trademark Security Agreement;

NOW, THEREFORE, in consideration of the premises and to induce the Lenders, and the Administrative Agent to enter into the Credit Agreement and to induce the Lenders to make their respective extensions of credit to the Borrower thereunder, the Grantor hereby agrees with the Administrative Agent as follows:

Section 1. Defined Terms

Unless otherwise defined herein, terms defined in the Credit Agreement or in the Guarantee and Collateral Agreement and used herein have the meaning given to them in the Credit Agreement or the Guarantee and Agreement.

Section 2. Grant of Security Interest in Trademark Collateral

The Grantor, as collateral security for the full, prompt and complete payment and performance when due (whether at stated maturity, by acceleration or otherwise) of the Obligations of the Grantor, hereby mortgages, pledges and hypothecates to the Administrative Agent for the benefit of the Secured Parties, and grants to the Administrative Agent for the benefit of the Secured Parties a lien on and security interest in, all of its right, title and interest in, to and under the following Collateral of such Grantor (the "Trademark Collateral"):

(a) all of its Trademarks and Trademark Licenses to which it is a party, including, without limitation, those referred to on Schedule I hereto;

(b) all goodwill of the business connected with the use of, and symbolized by, each Trademark; and

(c) all Proceeds of the foregoing, including, without limitation, any claim by Grantor against third parties for past, present, future (i) infringement or dilution of any Trademark or Trademark licensed under any Trademark License or (ii) injury to the goodwill associated with any Trademark or any Trademark licensed under any Trademark License.

Section 3. Guarantee and Collateral Agreement

The security interest granted pursuant to this Trademark Security Agreement is granted in conjunction with the security interest granted to the Administrative Agent pursuant to the Guarantee and Collateral Agreement and the Grantor hereby acknowledges and affirms that the rights and remedies of the Administrative Agent with respect to the security interest in the Trademark Collateral made and granted hereby are more fully set forth in the Guarantee and Collateral Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein.

Section 4. Ownership of Trademarks

Nothing contained in this Agreement, the Credit Agreement, or the Guarantee and Collateral Agreement, nor any act, omission, or circumstance may be construed as: (a) directly or indirectly conveying to the Administrative Agent any rights in and to the Trademarks (other than the security interest granted pursuant to the Guarantee and Collateral Agreement and all rights with respect thereto) or (b) conveying to the Administrative Agent any right of prior approval of, or any right to prevent the granting of, or any right to rescind any license of any of the Trademarks granted by the Grantor or Grantors, including, without limitation, the License-Back (the "License-Back") to Jimmy Buffett pursuant to the Intellectual Property Contribution and License-Back Agreement dated as of December 20, 2006 by and between Jimmy Buffet and JB Intellectual Property, LLC and to which certain of the Trademarks are subject.

Section 5. Acknowledgement by Administrative Agent


The Administrative Agent acknowledges and agrees that the security interest granted herein, in the Guarantee and Collateral Agreement and in any related document is subject to the License-Back to Jimmy Buffett, and any and all rights of the Administrative Agent in the event of default by one or more Grantors shall be subject to Jimmy Buffett's rights under such License-Back. The Administrative Agent shall not sell or otherwise dispose of any Trademark Collateral unless the prospective assignee acknowledges that such prospective assignee's rights are subject to Jimmy Buffett's rights under the License-Back. The Administrative Agent agrees that Jimmy Buffett may rely on the acknowledgments and agreements of the Administrative Agent set forth herein.

B. TRADEMARK APPLICATIONS

See attached docket for all U.S. trademark applications and registrations made during the period of May 29, 2008 through January 15, 2009 (the "Covered Period").

C. TRADEMARK LICENSES

The following Trademark Licenses have been entered into (or amended) during the Covered Period.

1. Cancun Restaurant

Services and Sub-License Agreement, dated March 30, 2007 (executed in October 2008) (the "Agreement"), by and between Margaritaville Mexico, LLC and MV Cancun S.A. de C.V. Pursuant to the Agreement, Margaritaville Enterprises, LLC and Margaritaville Mexico, LLC granted to M.V. Cancun S.A. de C.V. an exclusive license to operate a Margaritaville restaurant in the Peninsula of Quintana Roo, Mexico using Margaritaville Enterprises, LLC's trademarks and the trade secrets, recipes, designs, intellectual property, and operating system used at Jimmy Buffett's Margaritaville in Orlando, Florida. The Agreement is effective as of March 30, 2007, for a ten-year term, with two ten-year renewal periods. This Agreement replaces the January 16, 2002 agreement between the parties (as amended) regarding the Cancun, Quintana Roo, Mexico restaurant.

The Agreement explicitly excludes the right to use CHEESEBURGER IN PARADISE as the name of a restaurant, the right to use MARGARITAVILLE as a promotional slogan in connection with the sale of margarita cocktails in restaurants in the U.S., the right to use DON'T STOP THE CARNIVAL for any goods and services, and the right to use A1A & Design for clothing and hats.

2. Honolulu Store

Trademark License Agreement, dated May 30, 2008 (the "TL Agreement"), by and between Margaritaville Enterprises, LLC and Margaritaville Store of Honolulu, LLC ("Honolulu"). Pursuant to the TL Agreement, Margaritaville Enterprises, LLC granted to Honolulu a non-exclusive, non-transferable license to use certain trade names, service marks and trademarks, in connection with the operation of a Margaritaville retail store in Honolulu, Hawaii, including the sale of branded products at the store. The TL

Agreement explicitly excludes the right to use the mark DON'T STOP THE CARNIVAL for any goods and services and CHEESEBURGER IN PARADISE as the name of a restaurant. The term of the TL Agreement is perpetual, unless terminated pursuant to certain termination provisions.

3. United Arab Emirates Restaurants

Trademark Sub-License Agreement, dated July 10, 2008 ("TSL Agreement"), by and between Margaritaville of Dubai, LLC and Seven Tides Limited. Margaritaville of Dubai, LLC granted to Seven Tides a license to use certain trade names, service marks and trademarks, the so-called "Margaritaville Restaurant concept" and operating system" and all elements thereof (including, without limitation, recipes, and operating technologies in connection with the operation of Margaritaville Restaurants) in all countries of the United Arab Emirates (except Oman, for which Seven Tides has a right of first refusal) (each country, a "ST Territory"; and collectively, the "ST Territories"). Subject to Margaritaville of Dubai, LLC's right to terminate the TSL Agreement with respect to certain ST Territories, the TSL Agreement is exclusive as to the ST Territories. The term of the TSL Agreement is ten years, with two, five-year renewals at the option of Seven Tides, if Seven Tides is in full compliance with all materials terms and conditions then applicable pursuant to the TSL Agreement; and the TSL Agreement is not otherwise terminated. As a material condition of the grant of the license, Seven Tides agrees that the Dubai Location will open by July 10, 2011.

The TSL Agreement explicitly excludes the right to use the mark DON'T STOP THE CARNIVAL for any goods and services and CHEESEBURGER IN PARADISE as the name of a restaurant.

4. License Agreement Between Margaritaville Footwear, LLC and ACI International - Extension

Amended and Restated License Agreement, dated July 19, 2004 (the "ARL Agreement"), between Margaritaville Footwear, LLC and ACI International, Inc. ("ACI International"), as amended by: (a) that certain letter delivered by Joel Feldman on December 2, 2006, signed by Scott Coble, Authorized Representative of ACI International; such letter replaced Margaritaville Holdings LLC with Margaritaville Enterprises, LLC as sublicensor of trademarks; and (b) Amendment to Amended and Restated License Agreement dated January 1, 2008.

Pursuant to the ARL Agreement, as amended, Margaritaville Footwear, LLC, a wholly-owned and licensed subsidiary of Margaritaville Enterprises, LLC, granted an exclusive license to ACI International to advertise, merchandise, promote, publicize, and sell footwear under the mark MARGARITAVILLE to mid-tier retailers (such as department stores, family footwear stores, sporting goods stores, specialty retailers and surf shops), clubs (such as Costco, Sam's, Price Club, etc.), and price retailers (such as T.J. Maxx, Ross, etc.), in any location where the mark is registered. The ARLA Agreement was entered into on July 19, 2004, for a term expiring on December 31, 2007. Pursuant to the amendment, dated April 30, 2008, and effective as of January 1, 2008

(executed in June 2008), the term has been extended through December 31, 2010.

5. License Agreement between Margaritaville Holdings LLC and Sirius Satellite Radio Inc. - Extension

License Agreement, dated April 27, 2005, between Sirius Satellite Radio, Inc. ("Sirius"), Margaritaville Holdings LLC and Jimmy Buffett, as amended by: (a) that certain letter delivered by Joel Feldman on December 5, 2006, signed by Scott Greenstein, President of Entertainment & Sports for Sirius Satellite Radio, Inc; such letter assigned the interests of Margaritaville Holdings LLC in the License Agreement to Margaritaville Enterprises, LLC; and (b) letter from Sirius to Margaritaville Holdings LLC dated July 14, 2008.

Margaritaville Enterprises, LLC granted Sirius a royalty free, license to use: (1) certain of the MARGARITAVILLE name and trademarks, and (2) certain of the PARROTHEAD name and trademarks, for the purposes of creating, producing, distributing, marketing, publicizing and promoting a full-time, Margaritaville-branded, commercial free radio channel for worldwide distribution as part of Sirius' satellite radio service, on the Internet, on DISH Network and other satellite and cable television systems (as part of a digital music package), via cell phones and other mutually agreed media, in each case solely as a continuous channel and only as part of a Sirius-branded content offering, including the exclusive right for Sirius to use the designation: "The Official Radio Partner of Margaritaville." The License Agreement was executed on April 27, 2005 for a term beginning on that date and continuing until the earlier of (a) three years from the Launch Date (defined as the initial public performance of the Channel on the Sirius Service); or (b) July 31, 2008. Pursuant to the July 14, 2008 letter, the Agreement has been extended until June 14, 2011.

6. Garden Fresh Salsa

Trademark Sublicense Agreement, effective as of December 10, 2007, by and between Margaritaville Foods, LLC and Garden Fresh Salsa Company, Inc. ("Garden Fresh"). Pursuant to a license from Margaritaville Enterprises, LLC, Margaritaville Foods, LLC grants to Garden Fresh an exclusive license in the United States and Canada (and their territories), to provide, label, package and distribute under the MARGARITAVILLE mark corn-based tortilla chips and pre-packaged, refrigerated (not shelf-stable) dips, spreads, hummus, guacamole and salsa that use avocados, cheese, chickpeas, and/or tomatoes as a primary ingredient in food products manufactured for human consumption. The Agreement is effective as of December 10, 2007, for a three-year term, with successive renewal periods of two years each, subject to Garden Fresh's compliance with certain performance criteria.
