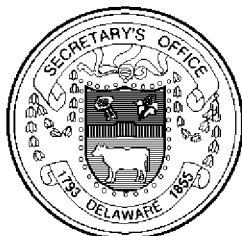



FOURTH AMENDED AND RESTATED CERTIFICATE OF INCORPORATION

MAGELLAN NAVIGATION, INC.

Magellan Navigation, Inc. (the "Corporation"), a corporation organized and existing under and by virtue of the Delaware General Corporation Law (the "DGCL"),

DOES HEREBY CERTIFY:

FIRST: That the directors of the Corporation, by written consent, duly adopted a resolution approving and adopting an amendment to the Fourth Amended and Restated Certificate of Incorporation of the Corporation. The resolution setting forth the proposed amendment is as follows:

"RESOLVED, that the Fourth Amended and Restated Certificate of Incorporation of the Corporation be amended (the "Amendment") by deleting Article First in its entirety and substituting in lieu thereof a new Article First to read as follows:

FIRST: The name of this Corporation is MNI, Inc.

THIRD: That the proposed amendment was duly adopted in accordance with the provisions of Section 242 of the DGCL.
