## TRADEMARK ASSIGNMENT

Assignor hereby covenants that it has full right to convey the entire interests herein conveyed and that it will execute such further documents as may be necessary to perfect the interests herein conveyed.

Assignor hereby authorizes and requests the United States Commissioner of Patents and Trademarks and any other similar government authority to record Assignee as the assignee and

owner of the Assigned Marks, and issue any and all registrations thereon to Assignee, as assignee of the entire right, title and interest in, to and under the same, for the sole use and enjoyment of Assignee and its successors, assigns or other legal representatives.

This instrument may be executed in counterparts, each of which will be deemed to be an original, and all of which together will constitute one and the same instrument.

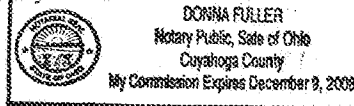
