ASSIGNMENT OF TRADEMARK

THIS ASSIGNMENT OF TRADEMARK ("Assignment") dated as of the 15<sup>TH</sup> day of MAY, 2009, effective May 11, 2009, is made and entered into by and between ST. RECITALS:

A. Assignor had adopted and used in its business the trademark, PACEL (the "TRADEMARK").

B. Assignor is currently the owner of U.S. Trademark Registration No. 1,539,220, issued May 16, 1989, for PACEL ("Registration").

C. It is Assignor's intention that the TRADEMARK and Registration be assigned to Assignee.

NOW, THEREFORE, in consideration of the terms and conditions of this Assignment, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties to this Assignment do hereby agree as follows:

1. Assignment of TRADEMARK and Registration. Assignor does hereby assign, transfer, convey and set over to the Assignee its entire interest in the TRADEMARK and the Registration, together with the goodwill of the business in connection with which such TRADEMARK is used, effective May 11, 2009.

2. Acceptance of Assignment. Assignee does hereby accept the assignment made by Assignor.

3. Benefit. This Assignment shall be binding upon and inure to the benefit of the parties to this Assignment and the successors and assigns of the parties to this Assignment.
