## ASSIGNMENT AND ASSUMPTION AGREEMENT

This ASSIGNMENT AND ASSUMPTION AGREEMENT (this "Assignment") is made this 1st day of January, 2007 (the "Effective Date") by and between Edward Cederquist, an individual whose principal residence is located in Naples, Florida ("Assignor") and Diet to Your Door d/b/a Bistro MD, a Nevada limited liability company ("Assignee").

### BACKGROUND:

A. Assignor is the owner of a federal trademark application for the mark BISTRO MD Serial No. 77055041 (the "Trademark Application");

B. Assignor desires to assign to Assignee all of Assignor's right, title, interest, estate, duties, liabilities and obligations in and to the Trademark Application, and Assignee desires to accept such assignment and to assume all of Assignor's right, title, interest, estate, duties, liabilities and obligations in and to the Trademark Application from and after the Effective Date as hereinafter defined.

NOW THEREFORE, in consideration of the covenants and obligations hereinafter set forth and other good and valuable consideration, the parties hereto, agree as follows:

1. Assignment and Assumption. Assignor conveys, transfers, assigns and sets over unto Assignee all of Assignor's right, title and interest in and to the Trademark Application and all rights and benefits therefrom. Assignee hereby expressly assumes, as of the Effective Date, all of the rights, title, interest and estate of Assignor under the Trademark Application and expressly agrees to perform the duties, liabilities and obligations of Assignor arising under the Trademark Application.

2. Warranties and Representations of Assignor. Assignor warrants and represents that he has:

- (a) the right, power and authority to execute and deliver this Assignment; and
- (b) made no prior assignment of the Trademark Application.


3. Warranties and Representations of Assignee. Assignee hereby represents to Assignor that Assignee is financially capable of performing the obligations assumed by Assignee under the Trademark Application.

4. Miscellaneous. This Assignment (a) shall be governed by the laws of the State of Florida; (b) shall be binding upon the Assignor and its successors and assigns; and (c) may not be amended except by a written agreement executed by the parties hereto.

5. Captions. The captions preceding the various paragraphs of this Agreement have been inserted solely for convenience of reference and shall not be used in construing this Agreement.


