ARTICLES OF AMENDMENT

IZI CORP., a Maryland corporation, having its principal office at Baltimore City, Maryland (hereinafter referred to as the "Corporation"), hereby certifies to the State Department of Assessments and Taxation of Maryland that:

FIRST: The Charter of the Corporation is hereby amended by deleting therefrom in its entirety Article SECOND and by substituting in lieu thereof the following new Article SECOND:


"SECOND: That the name of the Corporation (which is hereinafter called the "Corporation") is:

IZI MEDICAL PRODUCTS, INC."

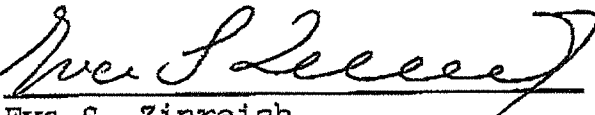
