

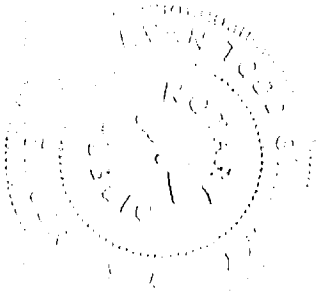

9) All accounts receivable now outstanding or hereinafter arising;


10) All contract rights and general intangibles now in force or hereinafter acquired.
