RELEASE AND REASSIGNMENT OF TRADEMARK

This RELEASE AND REASSIGNMENT OF TRADEMARK (this "Release and Reassignment") is made as of July 25th, 2007 by THE ROYAL BANK OF SCOTLAND plc (the "Bank"), in favor of THULE TOWING SYSTEMS LLC (formerly known as Thule Hitch Systems LLC), a Delaware limited liability company (the "Company").

PRELIMINARY STATEMENT

A. Company granted to the Bank a security interest in those certain trademarks, as described on Exhibit A attached hereto (the "Intellectual Property"), in order to secure certain financing arrangements provided to the Company by the Bank (the "Financing Arrangement") pursuant to that certain (a) Senior Credit Agreement by and among the parties named therein dated as of October 22, 2004 (as amended and restated on December 15, 2004, August 30, 2005, September 6, 2006, October 20, 2006 and June 1, 2007) and (b) Mezzanine Credit Agreement by and among the parties named therein dated as of October 22, 2004 (as amended and restated on December 15, 2004, January 5, 2005 and September 6, 2006). Such security interest in the Intellectual Property was recorded on September 6, 2006 with the United States Patent and Trademark Office at Reel and Frame Numbers, 003386 and 0253.

B. All of the loans made by the Bank to the Company have been paid in full, and the Financing Arrangement has been terminated. The Bank therefore wishes to release the security interest granted in the Intellectual Property, to reassign the Intellectual Property to the Company and to provide the Company with evidence of such release and reassignment in a form capable of recordation with the United States Patent and Trademark Office and the Bank consents that this Release and Reassignment be so recorded.

In consideration of the premises set forth herein and for other good and valuable consideration, the Bank hereby agrees as follows:

1. The Bank hereby releases its security interest in and to and lien on the Intellectual Property and reassigns all its right, title and interest in and to the Intellectual Property to the Company.
2. The Bank shall, at the Company's expense, take all further actions, and provide to the Company and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Company to more fully and effectively effectuate the purposes of this Release and Reassignment.
3. This Release and Reassignment shall be governed by and construed and enforced in accordance with the laws of the State of New York.



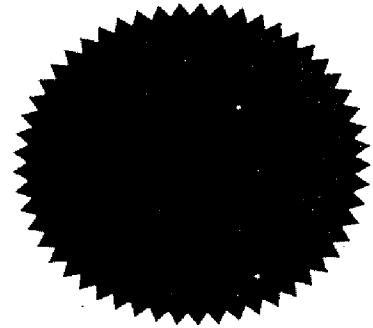


