TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

THIS TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT (this "Termination"), is dated as of June 19, 2009 (the "Effective Date"), and made by and among U.S. Bank National Association, a national banking association having an office at 425 Walnut Street, CN-WN-08, Cincinnati, Ohio 45202 ("Grantee"), Intelligrated Products, LLC, a Delaware limited liability company, with its chief executive office at 7901 Innovation Way, Mason Ohio 45040, and Intelligrated Systems, LLC, a Delaware limited liability company (collectively, the "Grantors" and each, individually, a "Grantor"), with its chief executive office at 7901 Innovation Way, Mason, OH 45040.

WHEREAS, pursuant to that certain Intellectual Property Security Agreement dated as of September 19, 2007, made by Grantors in favor of Grantee (the "Security Agreement"), a security interest was granted by the Grantors to Grantee in and to all of Debtors' right, title and interest in, to and under the "Collateral" (as defined in the Security Agreement), including the Intellectual Property (as hereinafter defined);

WHEREAS, the Security Agreement was recorded in the United States Patent and Trademark Office on October 3, 2007 at Reel and Frame 019910/0526 and 3633/0289; and

WHEREAS, Grantee now desires to terminate and release the Security Agreement;

NOW, THEREFORE, for good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured pursuant to the Security Agreement, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Grantee hereby states as follows:

1. Definitions. The term "Intellectual Property," as used herein, shall mean all of the Grantors' right, title and interest of every kind and nature as of the date hereof in the trademarks and patents listed on Schedule A hereto.
2. Release of Security Interest. Grantee hereby terminates the Security Agreement and terminates, releases and discharges its security interest in the Intellectual Property and reassigns to the person or persons legally entitled thereto all right, title and interest of Grantee in the Intellectual Property.
3. Representations and Warranties. Grantee represents and warrants that: (i) it has the full power and authority to execute this Termination; and (ii) it has not assigned, transferred, restricted or otherwise encumbered its rights under the Security Agreement.
4. Further Assurances. Grantee hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release contemplated hereby.
