TRADEMARK ASSIGNMENT

Seller agrees to perform all affirmative acts which may be reasonably necessary or desirable to assist Purchaser to perfect the above-described transfer of rights, or to secure registration before the United States Patent and Trademark Office or any foreign Office, at Purchaser’s expense, as well as to cooperate with Purchaser in obtaining and/or providing information required in any proceedings relating to the Trademarks, again at Purchaser’s expense.

Seller further authorizes the Commissioner of Patents and Trademarks of the United States and the appropriate official in any other country, to issue any and all trademark registrations, amended registrations and/or renewals that may be granted upon any application or petition for same, to Purchaser, and/or Purchaser’s successors and/or assigns.


