DECLARATION OF IAN LOVELESS, ESQ.

I, Ian Loveless, hereby declare as follows:

1. I am United Kingdom counsel for Cintel International, Ltd., the Assignee of all right, title and interest in the above-captioned registration. I am a partner of the U.K. firm Reddie & Grose, Chartered Trade Mark Attorneys (*inter alia*), having offices at 16 Theobalds Road, London WC1X 8PL, Tel: +44 (0)20 7242 0901, Fax: +44 (0)20 7242 3290.
2. Prior to November 14, 2007, I directed the firm of Ostrolenk, Faber, Gerb and Soffen, LLP to record an assignment of the above-captioned registration. A copy of that assignment is attached hereto as Exhibit A. Exhibit A was duly recorded in the USPTO on November 14, 2007, at Reel/Frame 3662/0975.
3. Earlier this year, it came to my attention that the Assignee was incorrectly named in the Assignment (Exhibit A). Specifically, the Assignee was named as "CINTEL INTERNATIONAL LIMITED COMPANY". This was incorrect, as the proper name for the Assignee is "CINTEL INTERNATIONAL LIMITED". There is only one company by the name of CINTEL INTERNATIONAL LIMITED, that is my client, the present Assignee. I am aware of no entity in the UK by the name of CINTEL INTERNATIONAL LIMITED COMPANY. In all other respects, the identifying information regarding the Assignee in the assignment (Exhibit A) is correct.
4. To the best of my knowledge, the Assignor, WARE REALISATIONS LIMITED, ceased to exist by operation of a Receivership shortly after the Assignment (Exhibit A) was

executed, and no individual is currently authorized to execute a Corrective Assignment on behalf of Assignor.

5. I make this declaration in support of a name correction of the Assignee recorded in the USPTO Assignment branch for the above-captioned registration, filed concurrently herewith.

I hereby declare that all statements made herein of my own knowledge are true and that all statements made on information and belief are believed to be true; and further that these statements were made with the knowledge that willful false statements and the like so made are punishable by fine or imprisonment, or both, under Section 1001 of Title 18 of the United States Code and that such willful false statements may jeopardize the validity of the application or document or any registration resulting therefrom.
