ASSIGNMENT AGREEMENT

THIS ASSIGNMENT (the "Assignment") shall be deemed made and entered into as of the 12 day of June, 2009, ("Effective Date") by and between H2O Pod Inc., ("Assignor"), and BRK Brands, Inc., a Delaware corporation, located at 3901 Liberty Street, Aurora, IL 60504-8122 ("Assignee").

Assignor hereby covenants and agrees that it will execute any and all instruments and documents reasonably necessary to aid the Assignee, its successors, legal representatives, and assigns, in the implementation and perfection of this Assignment.
