TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (this "Assignment") is made effective as of April 10, 2009, by and between SolarNet, Inc., a California corporation, having a principal place of business at 30 C Mill Street, Healdsburg, California 95448 ("Assignor"), and SolarNet, LLC, a California limited liability company with its principal offices at 1201 Morningside Drive, Suite 100, Manhattan Beach, California 90266 ("Assignee") in connection with that certain Asset Purchase and Contribution Agreement, dated as of the date hereof (the "Asset Purchase Agreement"), by and among Assignee, D.C. Power Systems, Inc., a Washington corporation, Stellar Energy Solutions, Inc., a California corporation, Assignor, and Mr. Joseph Marino. Capitalized terms used but not defined herein have the same meanings given to such terms in the Asset Purchase Agreement.

WHEREAS, Section 2.4 of the Asset Purchase Agreement requires Assignor to deliver at closing such further documents as might be required to reflect Assignor's assignment to Assignee of the trademark SOLARNET (Ser. No. 77/289448) (the "Mark"), along with the goodwill of Assignor's business symbolized thereby, and the portion of Assignor's business to which the Mark pertains; and

WHEREAS, the parties accordingly wish to execute this recordable instrument, assigning all of Assignor's right, title and interest in and to the Marks to Assignee;

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor and Assignee agree as follows:

1. Assignor hereby assigns, transfers and conveys to Assignee, free and clear of any Encumbrances, all of its right, title and interest in and to the Mark, including without limitation any and all registrations, applications, and/or common law rights for the Mark throughout the world, together with all of the goodwill of Assignor's existing and ongoing business symbolized by or associated with the Mark, and any and all income, royalties, damages and payments now or hereafter due and/or payable with respect thereto including, without limitation, damages and payments for past, present or future infringements.

2. Assignor and its successors and assigns shall execute and deliver to Assignee any further documents or instruments and shall take any reasonable actions which may be necessary to effect the foregoing assignment or the recordation or perfection thereof.
