**TERMINATION OF SECURITY INTEREST IN
INTELLECTUAL PROPERTY**

This Termination of Security Interest in Intellectual Property (the "Termination"), dated as of July 1, 2009, is executed by VENTURE LENDING & LEASING IV, INC., a Maryland corporation (the "Secured Party"), in favor of VOLTAGE SECURITY, INC., a Delaware corporation (the "Grantor").

RECITALS

A. In connection with that certain Loan and Security Agreement, dated as of September 25, 2006 (the "Loan Agreement") between Grantor and Secured Party, the Grantor and Secured Party entered into an Intellectual Property Security Agreement, dated as of September 25, 2006, as supplemented by a Supplement No. 1 thereto ("Supplement No. 1"), dated February 29, 2008 (as the same has been amended, supplemented and modified from time to time, the "Security Agreement") to secure the prompt and complete payment and performance of all of Grantor's Obligations (defined below) under the Security Agreement. All capitalized terms used herein without definition shall have the meanings ascribed to them in the Loan Agreement.

B. The Security Agreement was recorded with the Patent Division of the United States Patent and Trademark Office on October 24, 2006, at Reel/Frame 018454/0073 to evidence the security interest granted under the Security Agreement. Supplement No. 1 was recorded with the Patent Division of the United States Patent and Trademark Office on March 6, 2008, at Reel/Frame 020643/0069 to further evidence the security interest granted under the Security Agreement.

C. The Security Agreement was recorded with the Trademark Division of the United States Patent and Trademark Office on October 24, 2006, at Reel/Frame 3419/0079 to evidence the security interest granted under the Security Agreement.

D. Grantor has satisfied in full the Obligations (as defined in the Loan Agreement) under and secured by the Security Agreement and Secured Party has agreed to terminate and release its security interest in the Copyrights, Patents and Trademarks (as defined below) as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Secured Party expressly terminates and releases its security interest in, to and under the following (collectively, the "Copyrights", "Patents" and "Trademarks"):

a) Any and all copyrights, whether registered or unregistered, held pursuant to the laws of the United States, any State thereof or of any other country; all registrations, applications and recordings in the United States Copyright Office or in any similar office or agency of the United States, and State thereof or any other country; all continuations, renewals, or extensions thereof; and any registrations to be issued under any pending applications, including without limitation those set forth on Exhibit A attached hereto (collectively, the "Copyrights");

b) All letters patent of, or rights corresponding thereto in, the United States or any other country, all registrations and recordings thereof, and all applications for letters patent of, or rights corresponding thereto in, the United States or any other country, including, without limitation, registrations, recordings and applications in the United States Patent and Trademark Office or in any similar office or agency of the United States, any State thereof or any other country; all reissues, continuations, continuations-in-part or extensions thereof; all petty patents, divisionals, and patents of

addition; and all patents to be issued under any such applications, including without limitation the patents and patent applications set forth on Exhibit B attached hereto (collectively, the “Patents”);

c) All trademarks, trade names, corporate names, business names, trade styles, service marks, logos, other source or business identifiers, prints and labels on which any of the foregoing have appeared or appear, designs and general intangibles of like nature, now existing or hereafter adopted or acquired, all registrations and recordings thereof, and any applications in connection therewith, including, without limitation, registrations, recordings and applications in the United States Patent and Trademark Office or in any similar office or agency of the United States, any State thereof or any other country or any political subdivision thereof, and reissues, extensions or renewals thereof, and the entire goodwill of the business of Grantor connected with and symbolized by such trademarks, including without limitation those set forth on Exhibit C attached hereto (collectively, the “Trademarks”);

Secured Party authorizes and requests that the Commissioner for Patents and Trademarks and any other governmental officer record this Termination.
