RELEASE OF SECURITY INTEREST IN AND REASSIGNMENT OF TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN AND REASSIGNMENT OF TRADEMARKS (this "Release") is made as of July 13, 2009 ("Effective Date") by and between **Bank of America, National Association (as successor to Fleet National Bank)**, a national association, with an office at 200 Glastonbury Boulevard, Glastonbury, CT 06033 ("Lender"), and **Specialized Packaging Radisson, Inc.**, a New York corporation, with a mailing address of 777 Main Street, Hartford, Connecticut 06115 ("Assignor").

WHEREAS, pursuant to the terms and conditions of that certain Loan Agreement by and between Assignor and Fleet National Bank ("Fleet") dated August 4, 1998 (the "Loan Agreement"), Assignor and Fleet entered into that certain Collateral Assignment of Trademarks and Security Agreement by and between Assignor and Fleet dated August 4, 1998 (the "Trademark Assignment and Security Agreement");

WHEREAS, pursuant to the terms and conditions of the Trademark Assignment and Security Agreement, and in order to secure the complete and timely satisfaction of all Obligations (as defined in the Loan Agreement), Assignor granted, assigned and conveyed to Fleet the entire right, title and interest in and to the trademark applications and trademarks listed in the Schedule hereto, together with the goodwill associated therewith (the "Trademarks");

WHEREAS, contemporaneously with the Trademark Assignment and Security Agreement, Assignor and Lender entered into a Security Agreement under which Lender was granted a lien on and security interest in, among other things, the Trademarks;

WHEREAS, the Trademark Assignment and Security Agreement was recorded with the United States Patent and Trademark Office on August 20, 1998, at Reel/Frame 1773/0973; and

WHEREAS, Assignor has paid all of its outstanding indebtedness to Fleet and to Lender.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lender hereby (i) grants, assigns and conveys to Assignor the entire right, title and interest in and to the trademark applications and trademarks listed in the Schedule hereto, together with the goodwill associated therewith, (i) terminates the Trademark Assignment and Security Agreement and the Security Agreement, and (iii) hereby terminates, cancels and releases any and all security interests it has against the Trademarks.

Lender represents and warrants that: (i) it has the full power and authority to execute this Release; (ii) it has not assigned, transferred, restricted or otherwise encumbered any security interest it has against the Trademarks; (iii) it has not recorded or otherwise evidenced its security interest with respect to any trademark, or registration of an application to register any trademark, or any trade name or assumed name, other than those Trademarks set forth on the attached Schedule, in any jurisdiction throughout the world.

Lender shall take all further actions, and provide to Assignor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without

limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Assignor to more fully and effectively effectuate the purposes of this Release.
